Friends Peace Teams is a Spirit-led organization working around the world to develop long-term relationships with communities in conflict to create programs for peacebuilding, healing and reconciliation. FPT's programs build on extensive Quaker experience combining practical and spiritual aspects of conflict resolution.

Rwanda -conducted 30 basic HROC-Workshops, in total over 724 people trained. In 2017, 480 children were trained as peer mediators and 3,789 visited the 5 Children's Peace Libraries.

Burundi -Friends Women's Association after 15 years of existence is running 4 programs: caring for HIV positive people, rape survivors support, improving women's reproductive health, and action on gender based violence. Innovations in Peacebuilding - Burundi (IPB) trained a total of 2,308 people of which 1,214 were male and 1,094 female.

Kenya -TCSC conducted 42 HROC basic, 62 AVP basic workshops, 29 AVP advanced workshops, 30 peace clubs, 30 health clubs, 79 citizen reporters, 39 pece dialogue, 33 listening session and 4 mediation trainings. In total over 2,000 trained through TCSC.

Uganda -The HROC program in Uganda sent 2 persons to Rwanda for the HROC-International training, and 4 basic workshops were held in the Northern of Uganda. The Bududa Vocational Institute and Children of Bududa programs continued their services to the local community. In total the Bududa Vocational Institute had 125 students in nursery teacher training, carpentry and joinery, building construction, computer studies, tailoring, and hairdressing.

4b (Code: AWP) (Expenses \$ 41,831 including grants of \$ _____) (Revenue \$ 34,408)

Friends Peace Teams Asia West Pacific Initiative worked in Nepal, Indonesia, the Philippines and Korea supporting nonviolence, peace, trauma healing, conflict transformation and social justice advocacy for landless or poor farming communities recovering from war or religious violence. We supported flooding relief activities in Nepal. We hosted a Nepalese partner's tour of the U.S. to visit resettled Bhutanese families, who have all been touched by suicide. We continue to develop and support pre-schools and after-school programs, inclusive of children with disabilities, as well as parent, family and teacher training based on peace and nonviolence.

4c (Code: PLA) (Expenses \$ 50,178 including grants of \$ _____) (Revenue \$ 44,252)

Friends Peace Teams Peacebuilding en las Americas (PLA) Initiative worked in Colombia, El Salvador, Honduras and Guatemala to promote and support Alternatives to Violence Project (AVP) workshops in areas most affected by armed conflict and crime. This included work in prisons, with indigenous and Afro-descendent rural communities, in gang-ridden urban neighborhoods, with high school students, women survivors of war, and persons with disabilities. Workshops provided tools for community-building, trauma healing and conflict transformation. To carry out this work, PLA had three part-time employees, an Initiative Coordinator, Financial Specialist, and Communications Specialist.

Every organization must complete and attach Schedule B to its Form 990, 990-EZ, or 990-PF, unless it certifies that it doesn't meet the filing requirements of this schedule by taking the following action:

- Answering "No" on Form 990, Part IV, *Checklist of Required Schedules*, line 2, or
- Checking the box on
 - Form 990-EZ, line H, or
 - Form 990-PF, Part I, *Analysis of Revenue and Expenses*, line 2.

See the separate instructions for these lines on those forms.

If an organization isn't required to file Form 990, 990-EZ, or 990-PF but chooses to do so, it must file a complete return and provide all of the information requested, including the required schedules.

Accounting Method

When completing Schedule B (Form 990, 990-EZ, or 990-PF), the organization must use the same accounting method it checked on Form 990, Part XII, *Financial Statements and Reporting*, line 1; Form 990-EZ, line G; or Form 990-PF, line J.

Public Inspection

Contributions

Contributions reportable on Schedule B (Form 990, 990-EZ, or 990-PF) are contributions, grants, bequests, devises, and gifts of money or property, whether or not for charitable purposes. For example, political contributions to section 527 political organizations are included. Contributions don't include fees for the performance of services. See the instructions for Form 990, Part VIII, line 1, for more detailed information on contributions.

General Rule

Unless the organization is covered by one of the *Special Rules* below, it must list in Part I every contributor who, during the year, gave the organization, directly or indirectly, money, **securities**, or any other type of property that total \$5,000 or more for the organization's **tax year**. In determining the total amount,

separate and independent gifts of less than \$1,000 can be disregarded.

For an organization described in section 501(c)(3) that meets the 33 $\frac{1}{3}$ % support test of the regulations under sections 509(a)(1) and 170(b)(1)(A)(vi), and not just the 10% support test (whether or not the organization is otherwise described in section 170(b)(1)(A)), list in Part I only those contributors whose contribution of \$5,000 or more during the tax year is greater than 2% of the amount reported on Form 990, Part VIII, line 1h(A), or Form 990-EZ, line 1. *An organization that claims the benefit of this special rule must either (1) establish on Schedule A (Form 990 or 990-EZ), Part II, that it met the 33 $\frac{1}{3}$ % support test for the current year or prior year, or (2) check the box on Schedule A (Form 990 or 990-EZ), Part I, line 7 or 8, and the box on Schedule A, Part II, line 13, as a section 170(b)(1)(A)(vi) organization in its first five years.*

Example. A section 501(c)(3) organization, of the type described above, reported \$700,000 in total contributions, gifts, grants, and similar amounts received on Form 990, Part VIII, line 1h. The organization is only required to list in Parts I and II of its Schedule B each person who contributed more than the greater of \$5,000 or 2% of \$700,000 (\$14,000) during the tax year. Thus, a contributor who gave a total of \$11,000 wouldn't be reported in Parts I and II for this section 501(c)(3) organization. Even though the \$11,000 contribution to the organization was greater than \$5,000, it didn't exceed \$14,000.

Section 501(c)(7), (8), or (10) organizations. For contributions to these social and recreational clubs, fraternal beneficiary and domestic fraternal societies, orders, or associations that weren't for an exclusively religious, charitable, etc., purpose, list in Part I each contributor who contributed \$5,000 or more during the tax year, as described under *General Rule*, earlier.

For contributions to a section 501(c)(7), (8), or (10) organization received for use exclusively for religious, charitable, scientific, literary, or educational purposes, or for the prevention of cruelty to children or animals (sections 170(c)(4), 2055(a)(3), or 2522(a)(3)), list in Part I each contributor whose aggregate contributions for an exclusively religious, charitable, etc., purpose were more than \$1,000 during the tax year. To determine the more-than-\$1,000 amount, total all of a contributor's gifts for the tax year (regardless of amount). For a noncash contribution, complete Part II.

All section 501(c)(7), (8), or (10) organizations that listed an exclusively religious, charitable, etc., contribution in Part I or II must also complete Part III to provide further information on such contributions of more than \$1,000 during the tax year and show the total amount received from such contributions that were for \$1,000 or less during the tax year.

However, if a section 501(c)(7), (8), or (10) organization didn't receive total contributions of more than \$1,000 from a single contributor during the tax year for exclusively religious, charitable, etc., purposes and consequently wasn't required to complete Parts I through III with respect to these contributions, it need only check the third *Special Rules* box on the front of Schedule B and enter, in the space provided, the total contributions it received during the tax year for an exclusively religious, charitable, etc., purpose.

Specific Instructions



Don't attach substitutes for Schedule B or attachments to Schedule B with information on contributors. Parts I, II, and III of Schedule B may be duplicated as needed to provide adequate space for listing all contributors. Number each page of each part (for example, Page 2 of 5, Part II).

Part I. In column (a), identify the first contributor listed as No. 1 and the second contributor as No. 2, etc. Number consecutively. In column (b), enter the contributor's name, address, and ZIP code. Identify a donor as "anonymous" only if the organization doesn't know the donor's identity.  - Form 990-PF, Part I, *Analysis of Revenue and Expenses*, line 2.

See the separate instructions for these lines on those forms.

If an organization isn't required to file Form 990, 990-EZ, or 990-PF but chooses to do so, it must file a complete return and provide all of the information requested, including the required schedules.

Accounting Method
